- the value for mortgage or lending purposes
- the value of property involved in a legal dispute
- the verification of damage claims for insurance purposes
- a consultation on property tax assessments, capital gains and other valuation issues
- determination of a property's value during an expropriation process.

A member of the Appraisal Institute of Canada – Nova Scotia (AIC-NS) will ensure your best interests are represented. Real estate appraisers work for only one person: you. It's their job to determine the market value of real estate so you know the true value of what you are buying or selling.

Members of AIC-NS have the education, experience and training they apply to complete your assignment. As a result, appraisers are current with changes in market trends and laws affecting real estate values. By combining their knowledge and expertise with a thorough investigation of the property, a real estate appraiser will give you a professional opinion that you can trust.

Knowledge is your greatest bargaining tool when buying real estate. You want to be sure you pay a fair price and are assured your potential purchase has a fairly negotiated value. Prudent purchasers should place the following condition clause into their Purchase Agreement:

"Subject to a full appraisal being performed and meeting or exceeding the agreed offer".

When you hire a member of AIC-NS to conduct an appraisal on your behalf, you are hiring:

- someone who has the education and training required to support their value estimates
- someone who adheres to a Code of Ethics and professional standards
